ADVISORY COMMITTEE REPORTS (Title I, Parent Advisory Committee, ELAC/DELAC):

Doreen Hom and Heather Dugdale gave a report from Parent advisory committee.

Parent Advisory Committee Report:

- Naviance - Committee is looking to see if a new contract is advisable
- Principal Coppo discussed: By Fall 2020 - There will be 3 years of science required:
 - 4 strands - Biology, Chemistry, Physics,

- HS course selection - New offerings (in sequence):
 - Adding a true College Prep Chemistry (currently the College Prep Chemistry offered at TPHS is above the Statewide College Prep Chemistry standards)
 - Honors Chemistry (New)
 - Current AP Chemistry (stays the same)
 - Classes will be in align to current State Standards.

ELAC/DELAC Committee Report::

Brenda Robinette gave a report from ELAC/DELAC committee.

- Student Success Presentation to Students/Parents
- EL Assessments will now be in Spring
 - CELDT Testing discontinued
 - EL students to take ELPAC assessment (instead of CELDT)
 - ELPAC test proctored in March to receive scores by June
- EL Meetings will now be held in Spring.
 - HS selection for MS students online in Spring
- Any Reclassifications of borderline EL students will be delayed until new ELPAC scores and grades support Reclassifications.

NEW BUSINESS:

- A. Review of data noted within SPSA goals
 - a. SPSA goals - Data Reviewed
 - i. Will use assessments
 - ii. 2409 - TPHS student enrollment (down over last 3 years)

- iii. 97.1% TPHS graduation rate
- iv. EL Data reviewed
 - 1. EL Reclassifications dropped
- v. Lag in data reported from State
- vi. Trends not all evident due to lack of data from new assessments
- vii. TPHS - AP tests very high passage rate (80% pass rate overall)
- viii. CAASPP - only 2 years of data
 - 1. Year one lacked validity due to first year of CAASPP implementation and lack of student population participation in recent standardized testing of any kind for multiple years.
 - 2. Every group tested is a different group (11th grade only)
 - 3. This year's group of 11th graders is the first valid group tested
 - 4. Move CAASPP testing to right before AP testing (doubles as AP testing prep)
 - 5. CAASPP testing will be proctored during English and Math classes so as to not impact AP classes

 - i. College and Career Pathways not listed on dashboard yet, but will be added (Principal Coppo noted)
 - ii. Chronic Absenteeism very high at TP 13.9%
 - 1. Will bring back Saturday School (not just punitive)

- a. Enforce after School detention
 2. School, not individual attendance numbers will now be public, may impact College acceptance rates.
 3. Multiple SSC members recommend that loss of revenue due to chronic absenteeism be announced to parents and students to drive home the importance of improving Chronic Absenteeism at TPHS.
 4. Make improved absenteeism a new SPSA Goal (Principal Coppo added)
